## **Evident Privacy Policy**

Evident Inc. (hereafter referred to as "Evident", "we", "us" or "our") is a digital technology company that provides, among other things, software, hardware, CAD designs, and workflow automations to dentists, labs and manufacturers.

Evident is aware of the importance of protecting individuals' privacy. We are committed to collecting, using and disclosing (collectively, "processing") personal information responsibly and in compliance with this Evident Privacy Policy ("Privacy Policy"). This Privacy Policy applies to our processing of personal information collected by us in relation to your use of our web site, or any of our services or systems.

By submitting personal information, you agree that we may process such personal information in accordance with this Privacy Policy and as permitted or required by law. If you disagree with anything in this Privacy Policy, do not provide us with personal information and do not use this web site or our services or systems. Subject to legal and contractual requirements, you may refuse or withdraw your consent to our processing of personal information by contacting our Privacy Officer, whose contact information is set out below at Section 14. If you refuse or withdraw your consent, we may not be able to provide you or continue to provide you with services or information which may be of value to you.

### 1. What Personal Information Do We Collect About You?

Personal information means any information which relates to a natural person and allows that person to be identified directly, or indirectly in combination with other information. It does not include personal information where all references to the identity of the relevant individual have been removed (i.e., anonymous personal information).

Without limitation, any of the following categories of information (which may constitute personal information) may be collected by us:

- **Identity information**: includes name, date of birth, gender, job title, profession and licence number, username and password;
- Contact information: includes email, address, postal code and telephone numbers;

- **Purchase information**: includes information about products/services you have purchased in the past including the date of your purchase, the price paid, and information about products/services that you prefer or that interest you;
- **Financial information**: includes credit / debit card or account information used for processing of payments;
- **Technical information**: includes internet protocol (IP) address and geolocation information, web browser type and version, operating system and/or device, cookies and other technology on the devices you use to access this web site. For more information on our use of cookies, see Section 10 below;
- Internet activity information: includes session information, such as page response times, download errors, length of visits to certain pages, page interaction information (such as scrolling, clicks, and mouse-overs), and methods used to browse away from the page;
- Patient information: includes any personal information pertaining to a patient that you
  may submit to the web site, including their name, contact information, patient ID, date of
  birth, dental scans, photos or images, prescriptions, surgical plans and any other
  information related to their personal health.
- Social media activity information: includes any personal information pertaining to the
  content created by individual consumers, such as online ratings, reviews, online
  message boards/forums, photos/video sites, and tags; and
- **Business activity information**: includes any personal information pertaining to the frequency of orders, the specific information on what the consumer orders, or any activity which involved in the engaging of services.

#### 2. How Do We Collect Your Personal Information

We use different methods to collect personal information from and about you including through:

#### Direct interactions.

You may give us personal information by corresponding with us or by using our services, including without limitation our web site's features and services. This includes personal information you provide when you:

- Sign-up for a user account on our web site and update such user account;
- · Contact us through a chat-box on our web site;
- Fill out a form or respond on social media;
- Input information into any of our software or systems;
- Speak directly with an Evident employee or Evident authorized representative;
- Input or upload any patient information through our web site; and

• Subscribe to our newsletter, respond to a survey, fill out a form, or otherwise input or upload information or files on our web site.

# • Automated technologies or interactions.

As you interact with our web site, we will automatically collect technical information and internet activity information about your equipment and browsing actions and patterns. We collect this information by using cookies, pixels, server logs and other similar technologies. We may also receive technical information about you if you visit other web sites employing our cookies. For more information on our use of cookies, see Section 10 below.

### 3. Purposes for the Processing of Personal Information

We may process personal information for the purposes for which it was collected, as set out in this Privacy Policy, for other purposes permitted by law, or for other purposes with your consent.

We may process personal information for the following purposes:

## 4. To Whom Do We Disclose your Personal Information?

We communicate personal information to third parties in the following circumstances:

- with our service providers who help us fulfil the purpose for which personal information
  was collected, including server hosting providers who help us store the personal
  information you have provided us and third parties who assist us in operating our web
  site:
- with service providers, such as Facebook, Google, and Instagram, that provide tools to analyze the behavior behind the profiles and characteristics of our web site's visitors to better understand them;
- to comply with our obligations under any law or regulation, investigation, subpoena or order of a court, tribunal or other administrative or governmental authority;
- with law enforcement or a government institution in order to investigate fraud or potential
  fraud, as well as any other violation of a law, regulation, or the terms and conditions of
  use of the web site, and/or in order to protect the rights, property, or safety of Evident, or
  partners or other individuals; and

 with an acquiring organization in the event of a proposed or actual purchase (including liquidation, realization, seizure, or repossession), concession, merger, business combination, or any other type of acquisition, liquidation, transfer, translational contract, or financing of Evident in whole or in part or of any property, share, assets, stock, or business of Evident.

#### 5. Cross-Jurisdictional Transfers

By providing us with personal information, you acknowledge and agree that such personal information may be transferred to other jurisdictions for processing and storage, including in servers located across Canada, Australia, the E.U. and in the United States, where laws regarding the protection of personal information may be less stringent than the laws in your jurisdiction. Further, such personal information may be accessible to law enforcement, national security authorities, and the courts of such jurisdictions. Where necessary to make such transfers, we will comply with our legal and regulatory obligations in relation to the personal information.

### 6. Protection of Your Personal Information

In compliance with HIIPA, to prevent unauthorized access or disclosure, maintain data accuracy and facilitate the appropriate use of data, Evident uses physical, technological and administrative procedures to attempt to protect the integrity of its web site and systems and the confidentiality of personal information that it processes. Nevertheless, Internet transmissions are never completely private or secure. Evident cannot be liable for any breaches of confidentiality due to system failures or unauthorized access by third parties.

## 7. How Long Will We Retain Your Personal Information?

We only keep personal information for as long as necessary and for the reasons it was collected, or for as long as required to comply with any applicable legal obligation and its documents retention policies. The length of time personal information is kept varies according to the nature of the information, and it may extend beyond the end of the relationship between an individual and us.

When the personal information collected is no longer required by us, the necessary procedures for destroying, deleting, erasing, or converting it into an anonymous form are applied.

### 8. Your Legal Rights

Subject to certain exemptions, to the extent permitted by applicable law, you have the following rights in relation to the personal information we hold about you:

### (a) Your right of access

At your written request we will inform you whether we hold personal information relating to you and if we do, you have the right to receive a general account of our processing of such personal information. If your request is made in writing, subject to applicable laws and the provisions of this Privacy Policy, we will also provide you with access to your personal information that is in our possession. Unless prohibited by law, a reasonable fee may be levied if you request the transcription, reproduction or transmission of such information and you will have to provide

information or documentation to verify your identity. We will inform you of the approximate cost before proceeding to respond to your request. The web site does not store any payment information.

Your rights to access your personal information are not absolute. Access can be denied for several different reasons under applicable legislation. If we deny your request for access to your personal information, we shall explain why.

## (b) Your right to rectification

If we hold personal information about you and you believe that it is not accurate, complete and up-to-date, you can request to have it rectified (or rectify it yourself via your account information page). If we discover that information is not accurate, complete and up-to-date, we will take reasonable steps to rectify it. We will also send any information that has been amended, where appropriate, to any third parties that have access to the information. If we refuse a request to rectify information, we shall explain why and we will make a note of this in your file (and forward such note to anyone else who received the earlier information).

## (c) Your right to withdraw consent

If we rely on your implicit or explicit consent as our legal basis for processing your personal information, you have the right to withdraw that consent at any time. However, this will not affect the lawfulness of any processing carried out before you withdrew your consent. If you withdraw your consent, we may not be able to provide certain products or services to you. We will advise you if this is the case at the time you withdraw your consent.

### 9. Links to Other Web Sites, Advertising, and Social Media

This web site may occasionally contain links to other web sites not operated by Evident. These third party web sites have separate and independent privacy policies, which you should review. We have no responsibility or liability for the content, privacy practices and activities of these web sites. Nonetheless, we seek to protect the integrity of our web site and welcome any feedback about such web sites.

This web site may display advertisements and/or links to third party sites. These advertisements or links may contain cookies placed by those third parties. Evident is not responsible for those advertisements, the web sites to which they are linked, or how any other linked sites, may use their own cookies or information. Google's use of the DART cookie enables it to serve ads to users based on their visit to this web site and other web sites on the Internet. The use of social networks in connection with Evident's web site may lead to the collection and exchange of some personal data between Evident and such social network. We invite you to read the privacy policy posted on social media websites to be aware of what personal information can be transmitted to Evident as well as the purposes of processing of your

personal information by such social media provider, in particular for advertising purposes. Evident shall not be responsible for any processing of your personal information by social networks on their account.

#### 10. Cookies

Evident (via this web site) may set and access "cookies" on your computer. Cookies are small files stored in your computer that identify users entering our web site. These files allow us to direct you to your preferred subsections of our web site and enable statistical analysis of how our web site is used. Only aggregated data, no individual records, will be used for this analysis.

You may delete cookies, however you may lose any information that enables you to access the web site more quickly.

You can choose to enable or disable cookies in your web browser. By default, your browser will accept cookies, however this can be altered. For further details please consult the help menu in your browser. Disabling cookies may prevent you from using the full range of services available on the web site.
